

## No. 56. THE DISEASES OF PLANTS PREVENTION LAW, 1893.

## DECLARATION

(under Section 2.)

W. D. BATTERSHILL,

In exercise of the powers vested in the Governor by the Diseases of Plants Prevention Law, 1893, His Excellency the Governor has been pleased to declare and hereby declares the area in the Schedule hereto to be a place infected with the disease *Lepidosaphes beckii* (known as Mussel scale).

## SCHEDULE.

Commencing at a point on the old road from Paphos to Limassol opposite the north-western corner of plot No. 418, sheet LIII, plan 61; thence south-eastwards along this road to the most southerly point of plot No. 389 of the same plan; thence north-eastwards following the boundaries of, and including to the area, plots Nos. 385, 386, 388, 381, 377 and 376 of the same plan to the north-eastern corner of plot No. 376, on the road from Kandou to Episkopi; thence southerly along this road to its junction with the old road from Paphos to Limassol; thence north-eastwards and eastwards along the latter road to its junction with the new main road from Paphos to Limassol, at the bridge over the Kouri River; thence southwards along the right bank of this river as far as the southerly corner of plot No. 174, sheet LVIII.5; thence westwards in a straight line to the south-western corner of plot No. 132 of the same plan; thence northwards in a straight line to the point of commencement.

The area comprises 1.03 square miles approximately as shown edged in red on a plan filed with the Director of Land Registration and Surveys.

## DECLARATION

(under Section 2.)

In exercise of the powers vested in the Governor by the Diseases of Plants Prevention Law, 1893, and of every other power hereunto enabling, His Excellency the Governor has been pleased to extend and hereby extends the area declared to be a place infected with the disease *Lepidosaphes beckii* (known as Mussel scale) under Government Notice No. 924 published in *Gazette* No. 2460 of 16th August, 1935, as follows:—

The area described in the Schedule appearing in the above Government Notice is enlarged to 7.84 square miles approximately by inserting in the 16th line and after the words "plot No. 26, plan No. LIX/2;" the following, viz.: "thence north-westwards along the left bank of this river as far as the most western point of the said plot No. 26, plan No. LIX/2, on the road from Limassol to Akrotiri village through the Government Plantations; thence south-westwards along this road as far as the south-western corner of plot No. 135, plan No. LIX.1; thence north-westwards all along the western boundary line of plots Nos. 135, 136, 130 revised, 95 and 95/3, plan No. LIX.1, as far as the north-western corner of plot No. 95/3 aforesaid, on the road from Limassol to Zakaki; thence north-westwards along this road as far as the point it crosses the diverted river 'Garillis'."

2. The additional area is shown edged in red on a plan filed with the Director of Land Registration and Surveys.

## No. 58. THE BURIALS LAWS, 1896 AND 1937.

## ORDER BY THE GOVERNOR MADE UNDER SECTION 14.
