No. 77. THE SALE OF FOOD AND DRUGS LAW, 1938.

REGULATIONS MADE UNDER SECTION 19.

J. V. W. Shaw,

Acting Governor.

I, the Acting Governor in Council, in exercise of the powers conferred by section 19 of the Sale of Food and Drugs Law, 1938, do hereby make the following regulations:—

1. These regulations may be cited as the Sale of Food and Drugs (Amendment) Regulations, 1941, and shall be read as one with the Sale of Food and Drugs Regulations, 1938, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Sale of Food and Drugs Regulations, 1938 and 1941.

2. The Schedule to the principal Regulations is hereby amended by the deletion therefrom of item No. 13 and of the provisions in the said item set out under the headings "Article of Food" and "Composition and Ingredients" and the substitution therefor of the following, to be inserted in the relevant columns under the appropriate heading:—

No.	Article of Food	Composition and Ingredients
13	Milk	 (a) Milk of cows: It shall contain not less than 8.0 per centum of milk solids other than milk fat and not less than 3.0 per centum of milk fat. (b) Milk of goats: It shall contain not less than 8.0 per centum of milk solids other than milk fat and not less than 3.5 per centum of milk fat. (c) Milk of sheep: It shall contain not less than 9.0 per centum of milk solids other than milk fat and not less than 5.5 per centum of milk fat: Provided always and in all cases that no milk shall contain any preservative, colouring matter or added water.
