

No. 92. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1941.

ORDER MADE BY THE GOVERNOR UNDER REGULATION 47.

I, the Governor, in exercise of the powers conferred by regulation 47 of the Defence Regulations, 1940 to (No. 1) 1941, do hereby order as follows:—

1. This Order may be cited as the Control of Trade by Sea Order, 1941.
2. Ships registered in the Colony shall not proceed to sea from any port whether within or outside the Colony except under the authority of a licence granted—
 - (a) by the Comptroller of Customs and Inland Revenue; or
 - (b) by any Collector of Customs.
3. A licence granted under this Order may contain such limitations and conditions as the authorities specified in clause 2 hereof may think fit to impose with respect to—
 - (a) the trades in which the ship may be engaged, and the voyages which may be undertaken by the ship;
 - (b) the class of cargoes or passengers which may be carried in the ship; and
 - (c) the hiring of the ship, and the terms upon which cargoes or passengers may be carried in the ship.
4. Any ship in respect to which a licence granted under this Order is in force shall comply with any directions given by the authorities specified in clause 2 hereof as to the ports to which the ship is to proceed for any particular purpose.
