The Quarantine Law, 1932.

NOTIFICATION UNDER SECTION 4.

In exercise of the powers vested in him by section 4 of the Quarantine Law, 1932, or otherwise, His Excellency the Governor is pleased to declare and it is hereby declared that the local areas in the first column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall, as from the date hereof, be subject to the measures prescribed by the Quarantine Regulations, 1932 to 1936, with respect to the dangerous infectious diseases in the second column of the Schedule hereto.

The Notification No. 432, published in Supplement No. 3 to the *Gazette* of the 20th November, 1940, is hereby cancelled.

THE DEFENCE REGULATIONS, 1940 to (No. 1) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Return of Stocks of Vetches) Order, 1941.

2. Within 15 days from the date of the publication of this Order in the *Gazette* every person (whether such person is a merchant, importer, dealer or otherwise) who has in his possession, or under his control, any quantity of vetches in excess of 100 okes shall complete and deliver—

(a) in the case of a person residing in, or carrying on business, in a town, to the Commissioner of the District in which such town is situated; or

(b) in the case of a person residing in, or carrying on business in a village, to the Mukhtar of the village in which he resides,

a return, in the form set forth in the Schedule hereto, in respect of the total quantity of vetches in his possession, or under his control.

3. Every person shall permit such person as I, or the Commissioner of the District, may authorize, by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been, or are being, complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under clause 2 of this Order.

4. Any person who—
 (a) acts in contravention of, or fails to comply with, any of the provisions of this Order; or
 (b) makes under clause 2 of this Order a return which is false in any material particular,
 shall be liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1941.
