THE CYPRUS VOLUNTEER FORCE LAWS, 1940 TO (No. 2) 1941.

PROCLAMATION MADE UNDER SECTION 11A.

Whereas by section 11A of the Cyprus Volunteer Force Laws, 1940 to (No. 2) 1941, it is enacted that the Governor may, by Proclamation, call out and mobilize the Force or any part thereof for actual service whenever it appears advisable to do so :

And whereas it appears to me advisable to call out and mobilize certain officers and other ranks :

Now, therefore, I, Charles Campbell Woolley, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, in exercise of the powers vested in me by section 11A of the said Cyprus Volunteer Force Laws, 1940 to (No. 2) 1941, do hereby, by this Proclamation, call out and mobilize the officers and other ranks whose names and particulars are set out in the first column of the Schedule hereto for the period set out in the second column of the said Schedule.

This Proclamation shall be deemed to have come into operation on the 17th day of April, 1942.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations :—

1. These regulations may be cited as the Certification of Signatures (His Majesty's Forces) Regulations, 1942.
2. Notwithstanding anything contained in any Law or public instrument, the signature of any member of His Majesty's Forces shall be deemed to be duly certified for all purposes if certified by the officer commanding his unit.
3. These regulations shall be deemed to have been made on the 1st day of January, 1942.
