

No. 128. Notification under the Tree Planting Village Areas Laws, 1930 to 1936.**TOKHNI (LARNACA) FUND.**

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Tokhni, in the District of Larnaca (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the Village of Tokhni, as described in the Order of the Governor made the 28th day of March, 1942, and published under Notification No. 86 in Supplement No. 3 of 2nd April, 1942, published in *Gazette* No. 2985 of 2nd April, 1942.

The Fund shall be under the management and control of the Commissioner of Larnaca for the time being.

The money in the Fund shall be utilized for encouragement of tree planting in the village of Tokhni.

The Schedule is hereby amended by the deletion therefrom of Part 6 and the substitution thereof of the following part:—

"PART 6.—COFFEE.

<i>Price when ground.</i> 39 piastres per oke.	<i>Retail Price.</i> 29 piastres per oke.	<i>Wholesale Price.</i> 26 piastres per oke, gross for net.

In this Part of the Schedule—

the term 'wholesale' means sale or purchase of coffee in quantities in excess of 10 okes at any one time or at any single transaction.

No. 130. THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1942.**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Prohibition of Reeling of Silk Cocoons) Order, 1942.

2.—(a) From and after the date of the publication of this Order in the *Gazette* no person shall reel any silk cocoons save under a special permit issued under my hand.

(b) Every special permit issued under the provisions of paragraph (a) hereof may contain such terms and conditions as may be specified therein.

3. Every person shall permit such person as I or the Commissioner of the District may authorize by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

4. Any person who acts in contravention of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 4) 1942.
