

No. 131. THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Licensing of Dealers of Certain Goods) Amendment Order, 1942, and shall be read as one with the Defence (Licensing of Dealers of Certain Goods) Order, 1942 (hereinafter referred to as the "principal Order"), and the principal Order and this Order may together be cited as the Defence (Licensing of Dealers of Certain Goods) Orders, 1942.

2. Clause 7 of the principal Order is hereby amended by the deletion therefrom of the words from "Upon the cancellation" to "that is to say:—" (in lines 1 and 2) and the substitution therefor of the following words:—

"7. Upon the conviction by a Court of any person for any contravention of clause 2 of this Order, or upon the cancellation of a licence issued to any person the following provisions shall have effect, that is to say:—".

3. The First Schedule to the principal Order is hereby amended by the deletion therefrom of item 6 and the substitution therefor of the following item:—

"6. Cloth, textiles, woven fabrics and wearing apparel of every description."

| In respect of sales to consumers only .. | 7½ piastres per oke. |
| 7. FRESH BROAD BEANS (KOUKKIA): | |
| In respect of sales to consumers only .. | 3½ piastres per oke. |
| 8. KOLOKASS: | |
| In respect of sales to consumers only .. | 6½ piastres per oke." |
