### No. 159. THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1942.

Delegation of Power under paragraph (5) of Regulation 66.

#### C. C. WOOLLEY,

Governor.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 4) 1942, do hereby depute the Cereals Controller to exercise and perform on my behalf the power to requisition wheat and barley and the powers connected with such requisitioning which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 4) 1942.

2. Nothing in this Order contained shall affect the operation and validity of the Orders published under Notifications Nos. 329, 93, 146 and 153 in Supplement No. 3 to the *Gazettes* of the 23rd August, 1940, the 30th April, 1941, the 18th June, 1941 and the 25th June, 1941, respectively.

No. 160. L THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Locally Grown Cereals Movement and Control) Order, 1942, and shall be read in conjunction with the Defence (Locally Grown Cereals Control) Orders, 1942, and the expressions "Cereals", "Cereals Controller" and "Cereals Control Officer" in this Order shall have the same meaning as in the said Orders.

2. This Order shall come into operation on the date of its publication in the Gazette.

3. No person shall, save with a written permit issued by the Cereals Control Officer of the area in which the cereals have been grown, and subject to such conditions as may be stated therein, remove or permit or suffer to be removed any unthreshed cereals from any such area to any area in any of the villages exempted from the operation of this Order as in clause 9 hereof provided.

4. No person shall, save with a written permit issued by a Cereals Control Officer, winnow any cereals.

5. No person shall, save under a written permit issued by a Cereals Control Officer, and subject to such conditions as may be stated therein, remove or permit or suffer to be removed any cereals or any straw from any threshing floor or place where the cereals have been threshed; provided that no removal of such cereals shall in any case take place between the hours of sunset and sunrise.

6. No person shall, on any threshing floor or place where any cereals have been or are being threshed, mix or permit or suffer to be mixed any wheat with any barley or other substance.

7. Every person threshing any cereals shall cause the cereals to be cleaned on the threshing floor or place where the cereals are threshed so that the cereals shall not contain more than four per cent. of foreign ingredients or extraneous matter.

8. No person shall sell, offer for sale, attempt to sell or make any arrangements to sell either directly or indirectly any Cyprus grown wheat save under a permit in writing given by the Cereals Controller.

9. The provisions of this Order shall not apply to cereals grown in any of the villages set out in the Schedule to the Defence (Locally Grown Cereals Control) Orders, 1942, or in such other village as may be exempted by the Cereals Controller.

10. Any person who acts in contravention of the provisions of this Order or of any condition in any permit issued under the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 4) 1942.
