DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 4) 1942, do hereby depute the persons for the time being holding the office designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 4) 1942.

To requisition any goods contained in the Schedule to the Defence (Licensing of Dealers of Certain Goods) Orders, 1942 to (No. 2) 1942, and any other goods which may, from time to time, be added to the said Schedule, and the powers connected with such requisitioning conferred by paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 4) 1942.

The Irrigation Divisions (Villages) Law, 1938.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, 1938, the following rules made by the Committee of the Irrigation Division of Kapilio, in the District of Limassol, are published in the Gazette.

IRRIGATION DIVISION OF KAPILIO.

Rules.

1. These rules may be cited as the Irrigation Division of Kapilio (Amendment) Rules, 1942, and shall be read as one with the Irrigation Division of Kapilio Rules, 1931 to 1933 (hereinafter called "the principal Rules"), and the principal Rules and these rules may be cited as the Irrigation Division of Kapilio Rules, 1931 to 1942.

2. The following rule shall be substituted for rule 5 of the Principal Rules:

"5. Every proprietor mentioned in the list shall pay a rate not exceeding nine shillings per annum, as may be prescribed by the Committee from time to time for every Government donum of land owned by such proprietor which is benefited or is capable of being benefited by the works."
