- (c) Clubs.
- (d) Hotels, inns, khans, restaurants, cookshops and cafés.
- (e) Premises occupied by medical practitioners, dentists or advocates in connection with the exercise of their work or profession.
- (f) Chemists and druggists shops or stores.
- (g) Offices of shipping and travelling agencies.
- (h) Offices of agencies for the hire of motor cars.
- (i) Ice factories.
- (j) Public baths.
- (k) Aerodromes.
- (l) Undertakers premises.

No. 196. THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1942.

ORDER MADE UNDER REGULATION 55.

I, the Governor, in exercise of the powers conferred by regulation 55 of the Defence Regulations, 1940 to (No. 4) 1942, do hereby order as follows :—

1. This Order may be cited as the Defence (Control of Use of Motor Vehicles Order, 1941) Continuance Order, 1942.

2. Notwithstanding anything contained in clause 6 of the Defence (Control of Motor Transport) Order, 1942, the Defence (Control of Use of Motor Vehicles) Order, 1941, shall remain in force and have full effect until the 30th day of June, 1942.
