THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2045
MADE UNDER SECTION 3.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Main State Forests Amendment (No. 1) Order, 1942, and shall be read as one with the Main State Forest (Adelphi Group) Order, 1941, (No. 1985), the Main State Forest (Makheras and Stavrovouni Group) Order, 1941, (No. 1986), the Main State Forest (Paphos Group) Order, 1941, (No. 1987), the Main State Forest (Halevga and Koronia Group) Order, 1941, (No. 1992), and the Main State Forest (Apostolos Andreas Group) Order, 1941, (No. 1994) (hereinafter collectively referred to as "the principal Orders").
