THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 1.

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1. These regulations may be cited as the Suspension (Railway) Regulations, 1942.

2. The operation of the provisions of the Railway Regulations, 1939 to 1941, set out in the first column of the Schedule hereto shall, during the continuance in force of these regulations, be suspended to the extent set out in the second column of such Schedule.

(a) Part III	(a) The asterisks appearing next to some commodities and the words "with or without Collection and Delivery" (at the foot of each page referring to such asterisks).

(c) Part VIII	(c) The whole.
(d) Part IX	(d) The whole.

Part II	Sub-paragraphs (a) to (d) both inclusive of paragraph (1).
