## ORDER MADE UNDER REGULATION 61.

In exercise of the powers vested in the Controller of Supplies under paragraph (1) of regulation 61 of the Defence Regulations, 1940 to (No. 5) 1942, duly deputed to me under paragraph (6) of the said regulation, I do hereby order as follows :-

1. This Order may be cited as the Control of Transport (Tyres) Order, 1942. 2. In this Order-

dealer in tyres" means any person who has in his possession or under his control any tyres or used tyres for the purpose of sale by wholesale or by retail; "mechanical vehicle" means any vehicle propelled on the road by a mechanical prime-mover;

"tyre" means any unused outer cover or inner tube intended for fitting or ordinarily fitted on mechanical vehicles; "used tyre" means any used outer cover and inner tube which having

at any time been fitted on to a mechanical vehicle has been, or is, removed from such vehicle or is, at the date of the publication of this Order in the Gazette, on any such vehicle.

3.--(1) As from the date of the publication of this Order in the *Gazette* no person shall withdraw any tyres from the Customs save under a special permit issued under my hand.

(2) A special permit issued under sub-clause (1) of this clause may be issued or refused at my discretion and may contain such terms and conditions (including the price at which the tyres are to be sold or purchased) as may be specified therein.

4. Within seven days from the date of the publication of this Order in the Gazette every person who has in his possession or under his control any tyres or used tyres shall complete and deliver to me a declaration in the form set forth in the Schedule hereto, in respect of all tyres and used tyres in his possession or under his control.

5.-(1) As from the date of the publication of this Order in the Gazette

(a) no person shall buy or otherwise acquire any tyre or used tyre unless he obtains a special permit from me for the purpose;

(b) no person shall sell or otherwise dispose of any tyre or used tyre except to a holder of a special permit from me, issued under paragraph (a).

(2) A special permit under paragraph (a) of sub-clause (1) of this clause may be issued or refused at my discretion and may contain such terms and conditions (including the price to be paid for any used tyre) as may be specified therein.

6. No person shall remove from, or fit on, any mechanical vehicle or remove from, or transfer to any place or store, any tyre or used tyre unless he obtains a special permit from me for the purpose.

7. No person shall buy or sell any used tyre at a price in excess of the price mentioned in a special permit issued under paragraph'(a) of sub-clause (1) of clause 5, or if no such price is mentioned, at a price exceeding 75% of the original retail price of such tyre.

8. Every dealer in tyres shall-

(a) exhibit and keep exhibited at a conspicuous part on his premises a list showing the maximum price at which such tyres or used tyres are offered for sale ;

(b) keep on his premises a register showing the name of the purchaser of every tyre or used tyre and the price at which the same has been sold.

9. Every person shall permit such person as I or the Commissioner of the District by the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of 10. Nothing in this Order contained shall apply to any tyres or used tyres which

are the property of the War Department or which are dealt with under the direct

authority of the Military Authorities : Provided that any person not being a member of His Majesty's Forces, who obtains or acquires any tyres or used tyres under the direct authority of the Military Authorities shall, as soon as he obtains or acquires any such tyres or used tyres, notify me in writing in that behalf.

11. Any person who acts in contravention of, or fails to comply with any of the provisions of this Order or of the terms or conditions contained in any permit issued under this Order, is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 5) 1942. 12. The Defence (Sale of Tyres) Control Orders, 1940 to 1942, are hereby revoked.
