APPOINTMENTS AND NOMINATIONS UNDER SECTION 4.

I, the Governor, in exercise of the powers conferred by section 4 of the Municipal Corporations (Appointment of Councils) Laws, 1938 and 1940, as amended by the Amendment of the Municipal Corporations (Appointment of Councils) Laws, 1938 and 1940, Regulations (No. 3) 1941, do hereby—

- (a) appoint the persons whose names appear in the second column of the Schedule hereto to be members of the Council of the Municipal Corporation of the town shown against their names in the first column of the said Schedule, to hold office with effect as from the 1st July, 1942; and
- (b) nominate from amongst such persons the persons shown as Mayor and Deputy Mayor in the second column of the said Schedule, to be the Mayor and Deputy Mayor in each such town, to hold office with effect as from the 1st July, 1942.

No. 235. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1942.

APPOINTMENT OF COMPETENT AUTHORITIES UNDER REGULATION 3.

I, the Governor, in exercise of the powers conferred by regulation 3 of the Defence Regulations, 1940 to (No. 6) 1942, and of every other power hereunto enabling, do hereby order as follows:—

The Schedule to the Notification No. 57, published in Supplement No. 3 to the Gazette of the 26th February, 1942, relating to the appointment of Central and District Boards as Competent Authorities for the purpose of fixing the maximum prices at which any goods or articles produced or grown in Cyprus or made or consisting of materials mainly produced or grown in Cyprus may be sold, is hereby further amended by the addition of the following names to the Boards of the respective Districts appearing therein:—
