or substituting the same, or which ply for hire within a radius of two miles from such municipal limits may carry twenty-five persons, including the driver thereof.

3. Regulation 31A of the principal Regulations (including the heading thereof) is hereby repealed.

THE ADULTERATION OF PRODUCE LAWS, 1926 TO 1935.

REGULATIONS MADE UNDER SECTION 10.

I, the Governor in Council, in exercise of the powers conferred by section 10 of the Adulteration of Produce Laws, 1926 to 1935, do hereby make the following regulations :-

1. These regulations may be cited as the Adulteration of Produce (Local Sales) (Amendment No. 2) Regulations, 1942, and shall be read as one with the Adulteration of Produce (Local Sales) Regulations, 1940 to 1942 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Adulteration of Produce (Local Sales) Regulations, No. 3: 1940 to (No. 2) 1942.
