

No. 26. THE DANGEROUS DRUGS LAWS, 1925 TO 1932.

ORDER MADE UNDER SECTION 13.

In exercise of the power and authority vested in him by section 13 of the Dangerous Drugs Laws, 1925 to 1932, His Excellency the Governor is pleased to order and it is hereby ordered as follows:—

1. The persons whose names appear in the Schedule hereto be and are hereby authorized to exercise, within the area or district appearing against the name of each such person in the third column of the said Schedule, all the powers conferred upon persons so authorized by section 13 of the said Laws.

2. The Order dated the 5th day of March, 1941, published under Notification No. 48 in Supplement No. 3 to the *Gazette* of the 12th March, 1941, is hereby revoked without prejudice to anything done thereunder.
