No. 263. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Legumes Returns of Stocks) Order, 1942.
2. In this Order—  
“legumes” means koukkia, lentils, louvana and chickpeas.

3. Any person who has in his possession or under his control any legumes in excess of 20 okes in the aggregate shall, not later than six days after the fifteenth day of each month commencing from the month of July, 1942, complete and deliver to me a return containing the particulars in the Schedule hereto :

Provided that any person who has completed and delivered a return under the Defence (Legumes Control) Order, 1942, hereby repealed, shall not be required to submit a return under this Order until not later than 6 days after the 15th day of August, 1942.

4. Every person shall permit such person as I, or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

5. Any person who—  
(a) acts in contravention of, or fails to comply with, any of the provisions of this Order, or  
(b) makes, under any of the provisions of this Order, a return which is false in any material particular,  
is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 6) 1942.

6. The Defence (Legumes Control) Order, 1942, is hereby repealed without prejudice to anything done or left undone thereunder.
