## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of New Bicycles) Order, 1942.
2. No person who has purchased a new bicycle in virtue of a special permit issued under the Defence (Controlled Goods) Orders, 1941 shall sell or offer for sale or attempt to sell or either directly or indirectly make any arrangement for the sale of such bicycle without my permission in writing previously obtained.
3. No person shall purchase or attempt to purchase or either directly or indirectly make any arrangement for the purchase of any bicycle bought by any person in virtue of a special permit issued under the Defence (Controlled Goods) Orders, 1941, unless the seller produces to the purchaser my permission in writing obtained under clause 2 of this Order.
4. Any person who acts in contravention of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 6) 1942.

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Returns of Stocks of Quinine) (Amendment) Order, 1942, and shall be read as one with the Defence (Returns of Stocks of Quinine) Order, 1942, (hereinafter called "the principal Order") and the principal Order and this Order may together be cited as the Defence (Returns of Stocks of Quinine) Orders, 1942.

2. Clause 2 of the principal Order is hereby amended by the deletion of the definition "Registered chemist and druggist" contained therein and by the substitution therefore of the following definition :—

"Registered chemist and druggist" means any person registered as chemist and druggist under the provisions of the Pharmacy Laws, 1900 and 1926, and includes any medical practitioner registered as such under the provisions of the Medical Registration Laws, 1936 and 1939 who is practising his profession in any village in which no chemist and druggist registered as such under the provisions of the Pharmacy Laws, 1900 and 1926, is carrying on business.

3. The First Schedule to the principal Order is hereby amended by the addition thereto of the following item :—

"16. Quinine Tannate."

Note.—For the first return to be made with regard to Quinine Tannate, under clause 5 of the principal Order, the quantities shown in column (2) of the Fourth Schedule to the said Order shall be the quantities held on the date of the publication of this Order.
