THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)
CONSOLIDATION ORDERS, 1940 AND 1941.

NOTICE No. 57 UNDER CLAUSE 13.

A.—The Schedule is hereby amended by the deletion therefrom of Part 17 and the substitution therefor of the following part:—

“PART 17.—LOCAL CHEESE.

(b) by the deletion therefrom of item 87 to Part 38 and the substitution therefor of the following item to be inserted in the appropriate columns of the said part:—

No. 30. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1941, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of Weekly Sales of Sugar) (Amendment) (No. 1) Order, 1942, and shall be read as one with the Defence (Control of Weekly Sales of Sugar) Orders, 1940 and 1941, (hereinafter called “the principal Order”) and the principal Order and this Order may together be cited as the Defence (Control of Weekly Sales of Sugar) Orders, 1940 to 1942.

2. Clause 3 of the principal Order is hereby amended by the deletion of the words “100 drams” and the substitution therefor of the words “50 drams”.

NOTICE NO. 3 UNDER CLAUSE 8.
