- (c) *3rd quality* : Sarpa, sorkos, mourmouros, stringles, skaros, palamida, melanoura, velonida, haradjida, litsa (large), supia, kalamari, octapodi and orphos
 (2 okes and over each) 27 piastres per oke.
 (e) *5th quality* : Vadi 12 piastres per oke.”

No. 294. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.

ORDER MADE BY THE CONTROLLER OF TRANSPORT UNDER
 REGULATION 55 (1) (c).

In exercise of the powers vested in the Governor by regulation 55 (1) (c) of the Defence Regulations, 1940 to (No. 7) 1942, which were duly delegated to me by the Order of the Governor dated the 17th day of June, 1942, and published under Notification No. 224 in Supplement No. 3 to the *Gazette* of the 18th of June, 1942, I, Philip Patrick Taylor, Controller of Transport, do hereby make the following order :—

1. This Order may be cited as the Defence (Charges for Carriage of Passengers and Goods by Motor Vehicles) Amendment Order, 1942, and shall be read as one with the Defence (Charges for Carriage of Passengers and Goods by Motor Vehicles) Order, 1942, (hereinafter called “the principal Order”), and the principal Order and this Order may together be cited as the Defence (Charges for Carriage of Passengers and Goods by Motor Vehicles) Orders, 1942.

2. Paragraph (2) of clause 3 of the principal Order is hereby deleted and the following paragraph substituted therefor :—

“ (2) Every passenger shall be entitled to carry with him free of any charge personal luggage not exceeding 15 okes in weight ; for any personal luggage carried by a passenger in excess of that amount a charge not exceeding 1 para per oke per mile may be made.”.

3. Paragraph (3) of clause 3 of the principal Order is hereby deleted and the following paragraph substituted therefor :—

“ (3) For goods and packages, not being personal luggage carried by a passenger, the following charges may be made :—

If the weight of such goods or packages—

(vi) exceeds 100 okes, the charges shall be the same as the charges in clause 4 of this Order prescribed.”.
