

**No. 317. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.****ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 7) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Labelling of Foodstuffs) Order, 1942.  
 2. In this Order the expression "foodstuffs" includes every article used for food or drink by man, other than drugs or water, and any article which ordinarily enters into or is used in the composition or preparation of human food or flavouring matters or condiments whether such foodstuffs are imported or locally grown or produced and whether or not a maximum price has been fixed for the sale thereof under any order in force for the time being.

3. From and after the 1st September, 1942, every person, who exposes for sale any foodstuffs shall display on each article a label whereon the selling price of such article is shown in large and legible characters:

Provided that where an article forms one of a group of articles of the same kind and price it shall be sufficient if one label showing the selling price is displayed on the group.

4. Any person who acts in contravention of, or fails to comply with, any of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 7) 1942.

**No. 318. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.****ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

1. This Order may be cited as the Defence (Sesame Control) Order, 1942.

2.—(a) From and after the date of the publication of this Order in the *Gazette* no person shall purchase any sesame or shall sell or otherwise dispose of any sesame to any person, except under a permit issued under my hand.

(b) Every permit issued under the provisions of paragraph (a) hereof may be either general or special and may contain such terms and conditions as may be specified therein.

3. Any person who acts in contravention of, or fails to comply with, any of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 7) 1942.

1. This Order may be cited as the Defence (Control of Meat) Amendment Order, 1942, and shall be read as one with the Defence (Control of Meat) Order, 1942, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Control of Meat) Orders, 1942.

2. Clause 3 of the principal Order is hereby amended by the deletion therefrom of the word "Tuesday" and the substitution therefor of the word "Wednesday".

3. Clause 4 of the principal Order is hereby amended by the deletion therefrom of the words "Monday or Tuesday" and the substitution therefor of the words "Monday or Tuesday or Wednesday".

4. Clause 5 (1) of the principal Order is hereby amended by the deletion therefrom of the words "Monday or Tuesday" and the substitution therefor of the words "Monday or Tuesday or Wednesday".
