

No. 334. THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 1.

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1.—(1) These regulations may be cited as the Defence (Suspension of Certain Provisions of the Petroleum Regulations, 1940 to 1941) Regulations, 1942, and shall be construed as one with the Petroleum Regulations, 1940 to 1941.

(2) The Interpretation Law, 1935, shall apply to these regulations as it applies to the interpretation of a Law.

2. During the continuance in force of these regulations:—

(a) regulation 107 of the Petroleum Regulations, 1940 to 1941, shall be suspended;

(b) regulation 109 of the Petroleum Regulations, 1940 to 1941, shall be suspended and the following regulation shall have effect in lieu thereof:—

“109. When petroleum is imported in bulk, its removal from the ship shall be effected in such manner and at such time as may be directed by the Director of Public Works.”

No. 335. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

This Order may be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Amendment (No. 1) Order, 1942, and shall be read as one with the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 and 1942, (hereinafter called “the principal Order”) and the principal Order and this Order may together be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 to (No. 1) 1942.

No. 336. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 7) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Sesame) (Amendment) Order, 1942, and shall be read as one with the Defence (Control of Sesame) Order, 1942, (hereinafter called “the principal Order”) and the principal Order and this Order may together be cited as the Defence (Control of Sesame) Orders, 1942.

2. The principal Order is hereby amended by the insertion therein after clause 2 of the following clause:—

“2A. From and after the 1st September, 1942, the sale of what are commonly known as *koullouria*, *sesamopittes*, *halva* and of every other kind of eatables containing sesame is prohibited: Provided that nothing in this clause shall affect the sale of sesame oil.
