DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 7) 1942, do hereby depute the persons for the time being holding the offices designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 7) 1942.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1.—(1) These regulations may be cited as the Defence (Pigeons and Doves Protection) Regulations, 1942.

(2) The Interpretation Law, 1935, shall apply to the interpretation of these regulations as it applies to the interpretation of a Law. 26 of 1935

2. Notwithstanding anything in any Law contained, no person shall at any time—

(a) shoot any pigeon or dove;

(b) have in his possession any pigeon or dove which has been shot;

(c) sell or expose for sale any pigeon or dove which has been shot; or

(d) kill, take or pursue any pigeon or dove unless such pigeon or dove is his own property, or he has authority from the owner of such pigeon or dove to kill, take or pursue the pigeon or dove, and the onus of proof shall be on the person charged to prove that he is the owner of such pigeon or dove or that he had such authority from the owner.

3. Any person who acts in contravention of any of the provisions of regulation 2 of these regulations shall be guilty of an offence and shall be liable, on conviction, to a fine not exceeding fifty pounds or to imprisonment for a term not exceeding six months, or to both such fine and imprisonment.
