**PROCLAMATION UNDER ARTICLE VA.**

Whereas by a Proclamation dated the 5th day of May, 1942, published in Supplement No. 3 to the *Gazette* of the 5th May, 1942, certain denominations of the currency notes issued by the Palestine Currency Board were declared to be current and legal tender in Cyprus :

And whereas it now appears to me to be expedient to declare the Palestine currency notes specified in the Proclamation in the First Recital of this Proclamation mentioned to be no longer current and legal tender in Cyprus :

Now, therefore, I, Charles Campbell Woolley, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, in exercise of the powers conferred by Article VA of the Cyprus Currency Notes Order and Law, 1928 and 1935, as amended by the Defence (Amendment of the Cyprus Currency Notes Order and Law, 1928 and 1935) Regulations, 1942, and of every other power hereunto enabling, do hereby order and proclaim as follows :—

1. The Currency Notes of the denominations of one Palestine pound and five Palestine pounds issued by the Palestine Currency Board declared to be current and legal tender in Cyprus by the Proclamation in the First Recital of this Proclamation mentioned shall cease to be current and legal tender in Cyprus after the 17th day of November, 1942.

2. All the said notes shall be presented for exchange to a Branch of the Ottoman Bank or to the office of the Commissioner of the District of Kyrenia, at Kyrenia, on or before the 17th day of November, 1942.

3. In case such notes cannot conveniently be exchanged at once from the balance in hand at any Branch of the Ottoman Bank or at the said Commissioner's office as aforesaid, a reasonable time shall be allowed for

a communication to pass from any such Branch or the Commissioner's office to the Headquarters with a view to obtaining the necessary balance for the exchange.

4. The Government shall be under no liability whatsoever in respect of any of the said notes not presented for exchange as aforesaid on or before the 17th day of November, 1942.

5. The Proclamation dated the 5th day of May, 1942, published in Supplement No. 3 to the *Gazette* of the 5th May, 1942, shall be revoked as from the 18th day of November, 1942.

**THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.**

**ORDER IN COUNCIL No. 2053.**

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Nicosia to contract a loan.*

I, the Governor in Council, in exercise of the powers conferred by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1941, do hereby order as follows :—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Nicosia (hereinafter referred to as "the Municipal Corporation"), shall be at liberty to borrow from the Bank of Cyprus Limited (hereinafter referred to as "the Bank"), the sum of three thousand pounds (£3,000) at a rate of interest not exceeding five per centum (5%) per annum subject to the following terms and conditions, that is to say,—

- (a) that the sum borrowed shall be repayable by the Municipal Corporation to the Bank in three equal annual instalments (comprising sinking fund and interest);
- (b) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual sum payable as aforesaid in the year to which such estimates relate;
- (c) that the sum borrowed shall be utilized by the Municipal Corporation for the purpose of repairs to the asphalted streets in Nicosia town.

2. That for the purpose of securing the repayment of the said sum of three thousand pounds the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Banker all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.
