**No. 394. THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 8) 1942, I hereby order as follows:—

1. This Order may be cited as the Control of Cattle and Meat (Amendment) Order, 1942, and shall be read as one with the Control of Cattle and Meat Order, 1942, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Control of Cattle and Meat Orders, 1942.

2. The principal Order is hereby amended by the insertion therein immediately after clause 7 of the following clause:—

" 8. Any person who—

(a) contravenes or fails to comply with any of the provisions of this Order;

(b) makes a return which is required to be made under this Order which is false in any material particular;

(c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 8) 1942."

**No. 395. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.**

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF  
LARNACA.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1941 and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Larnaca) Bye-laws, 1942, and shall be read as one with the Municipal Corporation (Larnaca) Bye-laws, 1931 to 1941 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Larnaca) Bye-laws, 1931 to 1942.

2. The following bye-laws shall be inserted in the principal Bye-laws immediately after bye-law 188.

" 188A.—No person shall make or attempt to make any street and house-to-house collection for any charitable, philanthropic or other purpose unless such person or the institution or society of which such person is a member shall have previously obtained a licence from the Council in that behalf.

188B.—Every such licence shall state the date or dates, the manner and the time or times at which the collection to which the licence relates shall be made, and may contain such other terms and conditions as the Council may in each case determine."
