

No. 4. THE ELEMENTARY EDUCATION LAWS, 1933 TO (No. 2) 1937.

NOTICE UNDER SECTION 73 (1).

It is hereby notified that in exercise of the powers vested in him by section 73 (1) of the Elementary Education Laws, 1933 to (No. 2) 1937, and otherwise, His Excellency the Governor is pleased to direct and hereby directs that the additional tax mentioned in section 65 of the said Laws payable by the Mohammedan taxpayers of the towns and villages mentioned in the Schedule hereto shall be increased by the rate per thousand shown opposite the name of each such town or village to provide the amount required for the payment of loans or annual maintenance of the Moslem Schools of the said towns and villages respectively.

No. 5. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1941.

ORDER MADE BY THE SUPERINTENDENT OF THE PORT OF FAMAGUSTA.

In exercise of the powers vested in the Governor by regulation 45 of the Defence Regulations, 1940 to (No. 6) 1941, which were duly delegated to me by the Order of the Governor dated the 22nd December, 1941, and published in Supplement No. 3 of the *Gazette* of the 31st December, 1941, under Notification No. 323, I, Archibald Benson Cavaghan, Superintendent of the Port of Famagusta, do hereby make the following order:—

PORT OF FAMAGUSTA.

PUBLIC TRAFFIC REGULATIONS.

1. Until further notice the following regulations are to be observed by all merchant vessels [see *definition paragraph 5*] approaching or moving within the limits of the Port of Famagusta.

2. The limits of the Port are bounded by a circle of 3 miles radius with its centre at the Jambulat Lighthouse at the south-eastern bastion.

3. The ordinary regulations of the Port are to be adhered to, except where varied by these regulations.

4. USE OF WIRELESS TELEGRAPHY, WIRELESS TELEPHONY AND SOUND SIGNALLING.
