**No. 405. THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.**

DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 8) 1942, do hereby depute the persons for the time being holding the offices designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 8) 1942.

2. The Order published under Notification No. 373 in Supplement No. 3 to the *Gazette* of the 28th September, 1942, is hereby revoked.

3. This Order shall be deemed to have been made and come into operation on the 28th day of September, 1942.

**THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.**

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 1.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1. These regulations may be cited as the Motor Car Regulations (Certain Modifications) Defence Regulations, 1942.

2. During the continuance of these regulations and notwithstanding anything contained in the Motor Car Regulations, 1930 to 1942—

(a) no certificate of competence to drive a motor car shall be issued by the Director of Public Works; and

(b) no licence to drive shall be granted by the Registrar of Motor Cars to any person who has not previously held a licence to drive;

without a special permit first obtained from the Controller of Transport.
