THE CYPRUS GOVERNMENT RAILWAY LAW, 1906.

REGULATIONS MADE UNDER SECTION 2.

Governor. I, the Governor in Council, in exercise of the powers conferred by section 2 of the Cyprus Government Railway Law, 1906, do hereby make the following

regulations :-1. These regulations may be cited as the Railway (Amendment No. 2) Regulations, 1942, and shall be read as one with the Railway Regulations, 1939 to 1942, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Regulations, 1939 to (No. 2) 1942.

2. Part V of the First Schedule to the principal Regulations (under heading "Rates for Vehicles on Wheels, etc.") is hereby amended by the deletion of paragraph (2) (b) and the substitution therefor of the following:

"(b) Bicycles accompanied by passengers will be charged at 3p. each, single journey only.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:-

1. These regulations may be cited as the Suspension Quarantine

(Public Health) Regulations, 1942.

2. The operation of clauses 2, 3 and 4 of the Quarantine (Public Health) Regulations, 1935 to 1941, shall, in so far as they relate to measles (item 14 in the First Schedule thereto), be suspended during the continuance in force of these regulations.
