THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1. These regulations may be cited as the Motor Car (Refund of Licensing Fees) Regulations, 1942.

2. During the continuance of these regulations and notwithstanding anything contained in the Motor Car Regulations, 1930 to 1942, every person who has not been granted a permit under the Defence (Control of Motor Transport) Order, 1942, (or any order amending, or substituted for, the same), to use his motor vehicle on any road in the Colony shall be allowed a refund in full of any licensing fee paid by him for such motor vehicle, in respect of each completed month still to run.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1.—(1) These regulations may be cited as the Elementary Education Laws, 1933 to 1937, (Amendment) Regulations, 1942, and shall be construed as one with the Elementary Education Laws, 1933 to 1937, (hereinafter referred to as “ the principal Law ”). Short title.

(2) The Interpretation Law, 1935, shall apply to the interpretation of these regulations as it applies to the interpretation of a Law. Interpreta-

2. Section 72 of the principal Law shall be amended and shall stand amended during the continuance in force of these regulations as follows:— Amend-

(a) by the deletion in sub-section (4) of the words “ shall be published by the Chairman of the Town Committee concerned in one issue of a Greek newspaper circulating in the Colony and also ” ;
and

(b) by the deletion therefrom of sub-section (13).
