THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 8) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of Slaughter of Cattle) Amendment Order, 1942, and shall be read as one with the Defence (Control of Slaughter of Cattle) Order, 1942, (hereinafter referred to as the "principal Order"), and the principal Order and this Order may together be cited as the Defence (Control of Slaughter of Cattle) Orders, 1942.

2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the word "four" (in line 6) and the substitution therefor of the word "two".

3. Clause 3 of the principal Order is hereby amended by the deletion therefrom of the words "clause 3" (in line 1) and the substitution therefor of the words "clause 2".
