## No. 459. THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 8) 1942, I hereby order as follows:—

- 1. This Order may be cited as the Defence (Bakery and Bread) Amendment (No. 2) Order, 1942, and shall be read as one with the Defence (Bakery and Bread) Orders, 1942, (hereinafter referred to as the "principal Order"), and the principal Order and this Order may together be cited as the Defence (Bakery and Bread) Orders, 1942 to (No. 2) 1942.
- 2. Clause 6 of the principal Order is hereby deleted and the following substituted therefor:—
  - "6. No registered baker shall keep, or allow or suffer to be kept in his bakery any bran or any flour other than—
    - (a) imported flour;(b) barley flour;
    - (c) whole wheat flour."

Modification: The above prices relate to the above types of local timber of average good quality. For the above types of local timber of low quality (commonly known as 'skarta') and of used local timber (commonly called 'metahirismena') the prices shall not exceed 65 per centum of the above prices."
