**THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.**

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:—

1. These Regulations may be cited as the Defence (Application of the Banking Business (Temporary Restrictions) Laws, 1939, to Co-operative Societies) Regulations, 1942, (Repeal) Regulations, 1942.

2. The Defence (Application of the Banking Business (Temporary Restrictions) Laws, 1939, to Co-operative Societies) Regulations, 1942, are hereby revoked.

**THE BANKING BUSINESS (TEMPORARY RESTRICTIONS) LAWS, 1939.**

ORDER MADE BY THE CONTROLLER OF BANKS.

In exercise of the powers vested in me by the Banking Business (Temporary Restrictions) Laws, 1939, and of every other power hereunto enabling, I, George Frederick Wilson, Controller of Banks, do hereby revoke the Order permitting Co-operative Societies to carry on banking business, which was published under Notification No. 255 in Supplement No. 3 to the *Gazette* of the 2nd July, 1942.

**No. 478. THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.**

**DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.**

*Governor.*

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 8) 1942, do hereby depute the Controller of Supplies to exercise and perform on my behalf the power to requisition cotton whether ginned or unginned, and cotton thread, cotton yarn and cotton piece goods, and the powers connected with such requisitioning which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 8) 1942.
