ORDER IN COUNCIL No. 2063 MADE UNDER SECTION 6.

I, the Governor in Council, in exercise of the powers conferred by section 6 of

Order, 1942.

2. There shall be charged a combined Postage and Air fee, in addition to late and/or registration fees, at the rates set forth in the third and fourth columns of the Schedule hereto, on letters, printed papers, commercial papers, samples, small packets and postcards intended for transmission by air mail to any of the countries of destination enumerated in the first column of the said Schedule, such transmission to be effected-

(a) by air or surface route from the Colony to Egypt or Palestine; and (b) from Egypt or Palestine to the country of destination either wholly by air

or partially by air and partially by surface route. 3. The Post Office (Air Mail Rato of Postage) Order, 1942, is hereby revoked.
