ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows :---

1. This Order may be cited as the Defence (Broom Making Control) Order, 1942.

2. For the purposes of this Order—

" broom making " means the manufacture of brooms from broom corn.

3.-(a) From and after the date of publication of this Order in the *Gazette* no person shall carry on the business of broom making save under a special permit issued under my hand to be granted or refused at my discretion upon application made in that behalf.

(b) Every special permit issued under the provisions of paragraph (a) hereof may contain such terms and conditions (including the price at which such brooms may be sold) as may be specified therein.

4. Every person shall permit such person as I or the Commissioner may authorize in writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

5. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this Order;
- (b) makes any false statement in any application for a permit under this Order ;
- (c) fails to comply with any condition in any permit issued under this Order;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under this Order;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 9) 1942.

THE DEFENCE REGULATIONS, 1940 TO (No. 9) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows :---

1. This Order may be cited as the Defence (Returns of Stocks of Broom Corn) Order, 1942.

2. For the purpose of this Order-

"Broom Corn " means the complete inflorescence (without seeds) of the plant Sorghum vulgare Pers.

3. Within seven days from the date of the publication of this Order in the *Gazette* every person who has in his possession or under his control any broom corn, shall complete and deliver to me a return in the form set forth in the Schedule hereto in respect of the broom corn in his possession or under his control.

4.—(a) From and after the date of the publication of this Order in the *Gazette* no person who has in his possession or under his control any

broom corn shall make use of or shall sell or dispose of any broom corn
to any person except under a special permit issued under my hand.
(b) Every special permit issued under the provisions of paragraph (a)

(b) Every special permit issued under the provisions of paragraph (a) hereof may contain such terms and conditions (including the price at which broom corn may be sold or purchased) as may be specified therein.

5. Every person shall permit such person as I or the Commissioner may authorize in writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under the provisions of this Order.

 $\hat{6}$. Nothing in this Order shall apply to manufactured broom corn or to broom corn which on the date of the publication of this Order in the *Gazette* has already been made up into any article or has already been utilised in connection with any article.

7. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this Order;
- (b) makes any return required to be made under this Order which is false in any material particular;
- (c) fails to comply with any condition in any permit issued under this Order;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under this Order;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 9) 1942.
