No. 523. BY THE GOVERNOR.
A PROCLAMATION.

Whereas by a Proclamation made the 22nd day of September, 1938, and published in Supplement No. 3 to the *Gazette* of the 23rd day of September, 1938, (hereinafter called "the First Proclamation"), it was ordered and proclaimed that on and after the 1st day of January, 1939, the boundary of the town of Nicosia should be as set forth in Schedule A to the said Proclamation and that the town of Nicosia comprised within the said boundary should be divided into quarters as set forth in Schedule B to the said Proclamation :

And whereas by subsequent Proclamations it was ordered and proclaimed that the First Proclamation should be amended in order to postpone its coming into operation until the 1st day of January, 1943 :

And whereas it has been made to appear to me desirable that the coming into operation of the First Proclamation should be further postponed for one year :

Now, therefore, in exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, do hereby order and proclaim that the First Proclamation shall be further amended by the deletion of the words "1st day of January, 1943," appearing therein and by the substitution therefor of the words "1st day of January, 1944,".

No. 524. THE POST OFFICE LAWS, 1881 TO 1933.

Notwithstanding anything contained in the Post Office (Rates of Postage and Postal Charges) Orders, 1940 and 1942, the charge for each letter posted in the Colony addressed to members of His Majesty's Forces, whether stationed in the Colony or abroad, shall be 2 piastres for the first ounce and $1\frac{1}{2}$ piastres for every additional ounce or fraction thereof.

No. 525. THE SAGE LEAVES (PROTECTION) LAW, 1942.

THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2066

MADE UNDER SECTION 3.

C. C. WOOLLEY,
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests Order, 1942.
2. The areas specified in the Schedule hereto are hereby declared to be Minor State Forests for the purposes of the Forest Law, 1939.

SCHEDULE.

Area situated within the lands of the village of—

1. *Lymbia in the District of Nicosia:*

Commencing at the most easterly corner of plot 184 of Government Survey Plan XL.9, the boundary of the area proceeds eastwards in a straight line a distance of 200 feet approximately to the north-west corner of plot 165 of the same plan; thence due south in a straight line a distance of 400 feet approximately; thence easterly in a straight line a distance of 400 feet approximately to the south-west corner of plot 164 of the same plan; thence following the southern boundary of this plot to its south-east corner; thence south-easterly a distance of 120 feet approximately to the stream bed; thence down the stream bed a distance of 40 feet approximately to the north-east corner of plot 397; thence westerly and southerly following the boundaries of, but excluding from the area, plots 377, 371 and 359 of the same plan; thence northerly following the boundaries of, but excluding from the area, plots 359, 167, 171 and 184 to point of commencement. The extent of the whole area is 22 donums approximately; it is part of plot 166 of Government Survey Plan XL.9 and lies within the village area of Lymbia.
