No. 526. THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2066

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests Order, 1942.
2. The areas specified in the Schedule hereto are hereby declared to be Minor State Forests for the purposes of the Forest Law, 1939.

SCHEDULE.

Area situated within the lands of the village of—

1. *Lymbia in the District of Nicosia:*

Commencing at the most easterly corner of plot 184 of Government Survey Plan XL.9, the boundary of the area proceeds eastwards in a straight line a distance of 200 feet approximately to the north-west corner of plot 165 of the same plan; thence due south in a straight line a distance of 400 feet approximately; thence easterly in a straight line a distance of 400 feet approximately to the south-west corner of plot 164 of the same plan; thence following the southern boundary of this plot to its south-east corner; thence south-easterly a distance of 120 feet approximately to the stream bed; thence down the stream bed a distance of 40 feet approximately to the north-east corner of plot 397; thence westerly and southerly following the boundaries of, but excluding from the area, plots 377, 371 and 359 of the same plan; thence northerly following the boundaries of, but excluding from the area, plots 359, 167, 171 and 184 to point of commencement. The extent of the whole area is 22 donums approximately; it is part of plot 166 of Government Survey Plan XL.9 and lies within the village area of Lymbia.

2. *Louroujina in the District of Nicosia :*

Commencing at the extreme westerly corner of plot 484 of Government Survey Plan XL.2, the boundary proceeds north-easterly in a straight line a distance of 1,450 feet approximately to the most northerly beacon of plot No. 506 of the same plan ; thence southerly and south-westerly following the boundaries of, but excluding from the area, plots 513, 514, 521 and 522 of the same plan to the point where the stream bed crosses the westerly boundary of plot 522 ; thence up this stream bed a distance of 50 feet to the fork in the stream ; thence following the right hand fork to point of commencement. The extent of the whole area is 20 donums, 1 evlek and 2,000 square feet approximately ; it is part of plot 497 of Government Survey Plan XL.2 and it is within the village area of Louroujina.

3. *Dhali in the District of Nicosia :*

Commencing at the north-west corner of plot 441 of Government Survey Plan XL.1, the boundary of the area proceeds southwards following the westerly boundaries of plots 441 and 490 of the same plan to the south-west corner of plot 490 ; thence westerly to the south-east corner of plot 491 of the same plan ; thence northerly following the easterly boundaries of plots 491, 492, 429, 425 and 424 of the same plan to a point on the easterly boundary of plot 425 situate 170 feet approximately north of the south-east corner of this plot ; thence north-easterly in a straight line a distance of 60 feet approximately to the westerly boundary of plot 430 of the same plan ; thence easterly following the boundary of plot 430 to point of commencement.

The extent of the whole area is 22 donums and 2,400 square feet approximately ; it is part of plot 480 of Government Survey Plan XL.1 and lies within the village area of Dhali.

4. *Tymbou in the District of Nicosia :*

All that area of plot 257 of Government Survey Plan XXII.59E.II, containing 13 donums, 2 evleks and 2,100 square feet approximately and situate in the village area of Tymbou.

5. *Kythrea in the District of Nicosia :*

Commencing at a point on the east side of the footpath and at the south-western corner of plot 122 of Government Survey Plan XIII.59w the boundary of the area proceeds eastwards along the south boundaries of plots 122 and 121 of the same plan to the footpath at the south-east corner of plot 121 ; thence southerly following the westerly side of this footpath to the north-east corner of plot 93 of the same plan ; thence westerly along the northern boundary of plot 93 to the south-east corner of plot 124 of the same plan ; thence northerly following the easterly boundaries of plots 124, 126, 128 and the footpath mentioned in the opening words of this description to point of commencement. The extent of the whole area is 12 donums and 2 evleks approximately ; it is part of plot 123 of Government Survey Plan XIII.59w and is situate in the village area of Khardhakiotissa Quarter of Kythrea.

6. *Dhenia in the District of Nicosia :*

Commencing at the north-west corner of plot 43 of Government Survey Plan XX.47, the boundary of the area proceeds north-easterly following the boundaries of plots 42, 31, 13/1, 15 and 14 of the same plan to the most easterly corner of the said plot 14 ; thence southerly a distance of 300 feet approximately to the north-west corner of plot 25 of the same plan ; thence south-westerly following the westerly boundary of plots 30 and 27 of the same plan a distance of 1,000 feet approximately ; thence westerly in a straight line a distance of 80 feet approximately to

the most northerly corner of plot 43 of the same plan ; thence south-westerly along the northern boundary of this Plot to point of commencement. The extent of the area is 22 donums and 3 evleks approximately, and it forms part of plot 13 of Government Survey Plan XX.47 locality " *Muttaes tis Dhenias* ".

7. *Mammari in the District of Nicosia :*

Commencing at the north-west corner of plot 553 of Government Survey Plan XX.48, the boundary of the area proceeds southwards, eastwards and southwards following the boundaries of plots 553, 561, 562, 561, 570, 574 and 575 of the same plan to the most southerly corner of the said plot 575 which is situate on the west side of the road leading from Mammari to Kokkini Trimithia ; thence southerly following the westerly boundary of this road to the north-east corner of plot 783 of the same plan ; thence westerly along the northern boundaries of plots 783 and 784 of the same plan to the north-west corner of the said plot 754 ; thence north-westerly following the edge of the escarpment which is the boundary of plot 787 of the same plan to the road leading south-west from Mammari to join the road from Kokkini Trimithia to Ayios Vasilios ; thence northerly following the east side of this road to point of commencement. The extent of this area is 20 donums and 1 evlek approximately, and it forms part of plot 787 of Government Survey Plan XX.48, in locality " *Laxia tou Neo Khoriou* ".

8. *Kokkini Trimithia in the District of Nicosia :*

The area comprises all the area of plots 515 and 513 of Government Survey Plan XX. 55, locality " *Kato Dhasos* ", being of an extent of 29½ donums approximately.

9. *Paleometokho in the District of Nicosia :*

Commencing at the north-east corner of plot 241 of Government Survey Plan XX. 63 which is on the boundary of the Railway Strip of the Cyprus Government Railway, the boundary of the area proceeds eastwards along the Railway Strip to the most northerly corner of plot 225 of the same plan ; thence southerly along the westerly boundary of this plot to its south-west corner ; thence westerly in a straight line a distance of 710 feet approximately to the most northerly corner of plot 236 of the same plan ; thence westerly following the northerly boundary of this plot to the road leading from Paleometokho to Dhenia ; thence northerly following the easterly boundary of this road to the most southerly corner of plot 237 ; thence easterly, northerly and easterly following the boundaries of plots 237, 239, 290 and 241 to point of commencement. The extent of this area is 24 donums and 1 evlek approximately and it is part of plot 227 of Government Survey Plan XX.63.

10. *Ayii Trimithias in the District of Nicosia :*

Commencing at the north-west corner of plot 439 of Government Survey Plan XXIX.24, the boundary of the area proceeds southerly, easterly and southerly following the boundaries of plots 439, 430, 440 and 427 of the same plan to the most westerly corner of the said plot 427 ; thence westerly along the north boundary of this plot to its north-west corner ; thence northerly following the easterly boundaries of plots 447 and 443 to the south-west corner of plot 388 of the same plan ; thence easterly, northerly and easterly following the boundaries of plots 388 and 402 to point of commencement. The extent of the area is 18 donums and 3 evleks approximately, and it is part of plot 473 of Government Survey Plan XXIX.24, locality " *Asproyi* ".

11. *Kormakiti in the District of Kyrenia :*

Commencing at the north-west corner of plot 337 of Government Survey Plan X.24E which is marked as Forest Cairn No. 3 on the said plan, the boundary follows the north boundary of this plot easterly a

distance of 500 feet approximately ; thence southerly in a straight line a distance of 340 feet approximately ; thence south-westerly in a straight line a distance of 450 feet approximately to the westerly boundary of the aforesaid plot at a point 500 feet approximately south of the starting point ; thence northerly along this boundary to the point of commencement. The extent of the area is 13 donums and 3 evleks approximately and it forms part of plot 337 of Government Survey Plan X.24E.

12. *Karpasha in the District of Kyrenia :*

Commencing at Forest Cairn No. 1 situated at the most north-eastern corner of the Karpasha Forest, locality " Toumboes ", the boundary of the area proceeds north-easterly following the village boundary between Dhiorios and Karpasha, being the northern boundary of plot 50 of Government Survey Plan XI.43w, a distance of 210 feet approximately ; thence south-easterly in a straight line a distance of 720 feet approximately ; thence south-westerly in a straight line a distance of 210 feet approximately to easterly boundary of the Karpasha Forest between Forest Cairns Nos. 1 and 2 ; thence northerly along the Karpasha Forest boundary a distance of 720 feet approximately to point of commencement. The extent of the area is 10 donums approximately and it forms part of plot 50 of Government Survey Plan XI.43w.

13. *Karavas in the District of Kyrenia :*

Commencing at the most north-westerly corner of plot 296 of Government Survey Plan XII.9E, the boundary of the area follows the northern boundary of this plot to its north-east corner ; thence due east in a straight line a distance of 60 feet approximately to the seashore ; thence northerly and north-easterly following the seashore a distance of 270 feet approximately ; thence westerly in a straight line a distance of 310 feet approximately to the seashore ; thence following the edge of the cliff to point of commencement. The extent of the area is 3 donums approximately and it forms part of plot 242 of Government Survey Plan XII.9E.

14. *Pileri in the District of Kyrenia :*

All that area of plot 82 of Government Survey Plan XII.41w, comprising 7 donums approximately, situated at locality " Mousa Tepesi " in the village of Pileri.

15. *Kalogrea in the District of Kyrenia :*

Commencing at the fork in the road from Trypimeni to Kalogrea where the road to Ayios Nikolaos Church leaves it in locality " Khourmala ", the boundary follows the southern boundary of this road north-easterly and easterly a distance of 700 feet approximately to the south boundary of plot 373 of Government Survey Plan XIII.24E ; thence easterly following the southern boundaries of plots 373 and 372 of the same Plan to the most easterly corner of plot 372 which is situated on the road leading south-easterly from Kalogrea ; thence along the southern boundary of this road to the most easterly corner of plot 361 of the same plan ; thence south-westerly and southerly following the easterly boundary of this plot a distance of 950 feet approximately ; thence westerly in a straight line a distance of 270 feet to point of commencement. The extent of the area is 10 donums and 3 evleks approximately and it is part of plot 361 of Government Survey Plan XIII.24E.

16. *Kissonerga in the District of Paphos :*

All that area in the village of Kissonerga, comprising 7 donums, 2 evleks and 1,800 square feet approximately, being part of plot 267 of Government Survey Plan XLV.34, registered in the name of the Government of Cyprus under Registration 5930, Kissonerga. The south-

east corner of the area is situated 300 feet approximately due west of a point on the boundary between plots 267 and 302 of the above-mentioned plan and 180 feet northwards along this boundary ; thence westerly in a straight line a distance of 450 feet (approximately) ; thence north-easterly in a straight line a distance of 300 feet approximately ; thence easterly in a straight line a distance of 300 feet approximately ; thence southerly in a straight line a distance of 300 feet approximately to point of commencement.

17. *Emba in the District of Paphos :*

All that area in the village of Emba being part of plot 80 of Government Survey Plan XLV.43, comprising 7 donums and 1,600 square feet approximately, the boundary of the area starts at a point on the eastern side of the road leading from Emba to Tala which point is opposite the north-east corner of plot 78 of the same plan ; thence easterly in a straight line the direction of which is a production of the boundary line between plots 71 and 78 of the same plan, a distance of 600 feet approximately ; thence south-easterly in a straight line a distance of 200 feet approximately ; thence westerly in a straight line a distance of 680 feet approximately to a point on the east side of the above mentioned road ; thence northerly along the eastern boundary of the said road to point of commencement.

18. *Trimithousa in the District of Paphos :*

Commencing at the most westerly corner of plot 230 of Government Survey Plan XLV.51, which point is on the left bank of the stream known as Vrissi tou Ayiou Yeorghiou, the boundary of the area follows this stream northwards a distance of 130 feet approximately to the point at which this stream forks to the east ; thence easterly along this fork a distance of 500 feet approximately to the footpath leading from Ayios Neophytos Monastery to the road from Trimithousa to Ktima ; thence southwards following the western side of this footpath a distance of 250 feet approximately ; thence westerly in a straight line a distance of 500 feet approximately to point of commencement. The area comprises plot 230 and parts of plots 231 and 232 of the aforesaid plan and contains 6 $\frac{3}{4}$ donums approximately.

19. *Yeroskipos in the District of Paphos :*

Commencing at a point on the village boundary between Konia and Yeroskipos, which point is situated at the most northerly corner of plot 140 of Government Survey Plan LI.12 ; thence south-westerly following the boundaries of, but excluding from the area, plots 140, 175 and 177 of the same plan to the most southerly corner of plot 177 ; thence westerly and northerly following the boundaries of, but excluding from the area, plots 176 and 179 of the same plan to the most north-easterly corner of plot 179 ; thence in a straight line to the most easterly corner of plot 26 of the same plan, this plot being excluded from the area ; thence north-westerly and southerly following the boundaries of, but excluding from the area, plots 42, 43, 44 and 45 of the same plan to point of commencement. The area contains 10 donums approximately and is part of plot 178 of Government Survey Plan LI.12 registered in the name of the Government of Cyprus under Registration No. 3545, Yeroskipos, of 20th August, 1926.
