

Cairn No. 6 ; thence south-easterly to Forest Cairn No. 5 ; thence westerly in a straight line to Forest Cairn No. 2 ; thence northerly to Forest Cairn No. 1 at point of commencement. The extent of the area is 18½ donums approximately, and lies in Government Survey Plan XLI.13 E & W.

3. *Xylophagou in the District of Larnaca :*

Commencing at a point on the northern boundary of the Xylophagou Forest between Forest Cairns Nos. 40 and 41 and 500 feet north-east of Forest Cairn 40, the boundary of the area proceeds north-easterly along the forest boundary to a point between Forest Cairns Nos. 41 and 42 to a point 500 feet north-east of Forest Cairn No. 41 ; thence south-eastwards a distance of 380 feet approximately ; thence south-westwards a distance of 700 feet approximately ; thence north-westwards a distance of 380 feet approximately to point of commencement. The extent of the area is 20 donums approximately, and it lies in Government Survey Plan XLII.25 E & W.

No. 530. THE FOREST REGULATIONS, 1940.

ORDER MADE BY THE GOVERNOR UNDER REGULATION 8 (1).

C. C. WOOLLEY,

Governor.

I, the Governor, in exercise of the powers conferred by paragraph (1) of regulation 8 of the Forest Regulations, 1940, do hereby direct that—

- (a) every Village Fuel Area reserved under Notification No. 529, published in Supplement No. 3 to the *Gazette* of the 24th day of December, 1942 ; and
 - (b) the Fund to be established in respect of every Village Fuel Area referred to in paragraph (a) hereof in accordance with the provisions of regulation 12 of the Forest Regulations, 1940 ;
- shall be under the control of the Village Commission of the village within the lands of which such area is situate, such area being the area set out in the Schedule to the Notification referred to in paragraph (a) hereof.

LIMITS OF THE MUNICIPAL CORPORATION OF NICOSIA.
