

**No. 537. THE DEFENCE REGULATIONS, 1940 TO (No. 9) 1942.****ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Sale of Quinine Control) Amendment (No. 2) Order, 1942, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Sale of Quinine Control) Orders, 1942 to (No. 2) 1942.

2. Clause 2 of the principal Order is hereby amended by the deletion of the definition "Director" contained therein and by the substitution therefor of the following definition :—

" 'Director' means the Director of Medical Services or any person authorized by him in writing in that behalf."

"(1) The term 'Director' means the Director of Medical Services or any person authorized by him in writing in that behalf."
