

**No. 540. THE DEFENCE REGULATIONS, 1940 TO (No. 9) 1942.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Milling of Flour) Amendment Order, 1942, and shall be read as one with the Defence (Milling of Flour) Order, 1942, (hereinafter referred to as the "principal Order") and the principal Order and this Order may together be cited as the Defence (Milling of Flour) Orders, 1942.

2. The principal Order is hereby amended by the deletion therefrom of clause 4 and the substitution therefor of the following:—

"4. No flour of ground wheat shall be taken or removed by any person from any mill unless such person before taking or removing it shall thoroughly and effectively mix such flour with the barley flour produced from the barley delivered in accordance with clause 3 of this Order."
