THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1939.

ORDER IN COUNCIL No. 2034

MADE UNDER SECTION 9A.

Authority to the Village Health Commission of Klirou to contract a loan.

C. C. WOOLLEY, Governor.

I, the Governor in Council, in exercise of the powers conferred by section 9A of the Public Health (Villages) Laws, 1936 to 1939, do hereby order as follows:—

The Village Health Commission of Klirou (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from Eleni Haji Michael of Klirou (hereinafter referred to as the "lender"), the sum of twenty pounds (£20) at the rate of interest not exceeding four per centum (4%) per annum subject to the following terms and conditions, that is to say:—

(a) the sum borrowed and the interest thereof shall be repayable by the Village Health Commission to the lender on the 1st day of November, 1942;

(b) the sum borrowed shall be utilized by the Village Health Commission for the improvement of the drinking water supply of the village of Klirou.
