ORDER IN COUNCIL No. 2069

MADE UNDER SECTION 3.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests Order, 1943.
2. The areas specified in the Schedule hereto are hereby declared to be Minor State Forests for the purposes of the Forest Law, 1939.

SCHEDULE.

Area situated within the lands of the village of—

1. *Akhyritou in the District of Famagusta :*

Commencing at a point in the Akhyritou Reservoir situated 500 feet due west of the north-west corner of plot 230 of Government Survey Plan XXXIII.17, the boundary of the area proceeds westerly in a straight line a distance of 420 feet approximately; thence south-easterly in a straight line a distance of 720 feet approximately; thence north-easterly a distance of 380 feet approximately; thence northerly in a straight line a distance of 500 feet approximately to point of commencement. The extent of the area is $14\frac{1}{2}$ donums approximately and it is situate in the village of Akhyritou, Famagusta District.

2. *Avgorou in the District of Famagusta :*

Commencing at the south-west corner of plot 147 of Government Survey Plan XX.48, the boundary of the area proceeds south-easterly following the easterly boundaries of plots 161 and 159 of the same plan to the south-east corner of the said plot 159; thence north-easterly following the northerly boundaries of plots 158, 157, 156, 155 and 154 of the same plan to the north-east corner of the said plot 154; thence northerly in a straight line in continuation of the direction of the easterly boundary of this plot a distance of 370 feet approximately to the southern boundary of plot 109 of Government Survey Plan XXXII.40; thence south-westerly following the south boundary of this plot and plots 151, 150, 149, 148 and 147 of Government Survey Plan XXXII.48 to the south-west corner of the said plot 147 at point of commencement. The extent of the area is $19\frac{1}{2}$ donums approximately and it is situate in the village of Akhyritou, locality Mavrospilios, Famagusta District.

3. *Sinda in the District of Famagusta :*

Commencing at the north-east corner of plot 282 of Government Survey Plan XXIII.50, the boundary of the area proceeds easterly and north-easterly along the southern boundary of plots 21 and 23 of

the same plan as far as a point distant approximately 130 feet from the south-east corner of the said plot 23 ; thence southerly in a straight line to the north-west corner of plot 230 of the same plan ; thence southerly and westerly following the boundaries of plots 230 and 270 of the same plan to a point on the boundary of the said plot 270 which is the south-east corner of plot 271 of the same plan ; thence north-westerly and northerly following the boundaries of plots 271, 272 and 282 of the same plan to the north-east corner of the said plot 282 at point of commencement. The extent of the area is $19\frac{1}{2}$ donums approximately and it is situate in the village of Vatili, locality Limni, Famagusta District.

4. *Strongylos in the District of Famagusta :*

Commencing at a point on the south boundary of plot 23 of Government Survey Plan XXIII.50, situate approximately 130 feet north-east of the south-east corner of this plot, the boundary of the area proceeds easterly along the south boundary of the said plot 23, a distance of 220 feet approximately ; thence southerly in a straight line to a point on the north boundary of plot 230 of the same plan, which point is 240 feet approximately from the north-west corner of the said plot 230 ; thence westerly along the north boundary of the said plot 230 to its north-west corner ; thence northerly to point of commencement. The extent of the area is 18 donums approximately and is situate in the village of Vatili, locality Limni, Famagusta District.

5. *Mousoulita in the District of Famagusta :*

Commencing at a point on the south boundary of plot 23 of Government Survey Plan XXIII.50 situate 350 feet east of the south-east corner of this plot, the boundary of the area proceeds eastwards along the south boundary of the said plot 23 a distance of 220 feet approximately ; thence southerly in a straight line to a point on the north boundary of plot 230 of the same plan situate 100 feet from its north-east corner ; thence westerly along the north boundary of the said plot 230 a distance of 220 feet approximately ; thence northerly in a straight line to point of commencement. The extent of the area is 18 donums approximately and it is situate in the village of Vatili, locality Limni, Famagusta District.

6. *Aphania in the District of Famagusta :*

Commencing at a point situate on the south boundary of plot 23 of Government Survey Plan XXIII.50 which point is approximately 80 feet west of the south-east corner of this plot, the boundary of the area proceeds eastwards along the south boundaries of plots 23 and 24 of the same plan to a point approximately 150 feet east of the south-west corner of the said plot 24 ; thence southerly in a straight line to a point on the north boundary of plot 228 of the same plan which point is approximately 120 feet east of the north-west corner of this plot ; thence westerly along the north boundary of the said plot 228 to its north-west corner ; thence southerly along the westerly boundary of the said plot 228 to the north-east corner of plot 230 of the same plan ; thence westerly along the northern boundary of the said plot 230 a distance of 100 feet approximately ; thence northerly in a straight line to point of commencement. The extent of the area is $18\frac{1}{2}$ donums approximately, and it is situate in the village of Vatili, locality Limni, Famagusta District.

7. *Asha in the District of Famagusta :*

Commencing at a point situate on the south boundary of plot 24 of Government Survey Plan XXIII.50, which point is approximately 150 feet from the south-west corner of this plot, the boundary of the area proceeds eastwards along the south boundaries of the said plot 24 and plot 25 of the same plan to a point on the boundary of the said plot 25 distant 100 feet approximately from its south-west corner ; thence southerly in a straight line to a point situate on the north boundary of plot 229 of the same plan, which point is 200 feet approximately from the north-west corner of the said plot 229 ; thence westerly and southerly along the

north and west boundaries of the said plot 229 to its south-west corner ; thence westerly along the north boundary of plot 228 to a point distant 120 feet approximately from its north-west corner ; thence northerly in a straight line to point of commencement. The extent of the area is $22\frac{3}{4}$ donums approximately, and it is situate in the village of Vatili, locality Limni, Famagusta District.

8. *Vatili in the District of Famagusta :*

Commencing at a point situate on the south-western boundary of plot 25 of Government Survey Plan XXIII.50, which point is approximately 100 feet from the south-west corner of this plot, the boundary of the area proceeds south-easterly to the south-east corner of the said plot 25 ; thence south-easterly along the west side of the road to the north-east corner of plot 206 of the same plan ; thence westerly along the north boundary of plot 206 to its north-west corner ; thence northwards along the road to a point opposite the north-east corner of plot 229 of the same plan ; thence westerly along the north boundary of the said plot 229 to a point 160 feet approximately from its north-east corner ; thence northerly in a straight line to point of commencement. The extent of the area is $22\frac{3}{4}$ donums approximately and it is situate in the village of Vatili, locality Limni, Famagusta District.

It is hereby notified for general information that in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940, His Excellency the Governor has been pleased to declare that the Minor State Forests, the areas of which are set out in the Schedule to the Minor State Forests Order, 1943, shall be reserved as Village Fuel Areas.

No. 3. THE FOREST REGULATIONS, 1940.

ORDER MADE BY THE GOVERNOR UNDER REGULATION 8 (1).

I, the Governor, in exercise of the powers conferred by paragraph (1) of regulation 8 of the Forest Regulations, 1940, do hereby direct that—

(a) every Village Fuel Area reserved under Notification No. 2 published in Supplement No. 3 to the *Gazette* of the 7th day of January, 1943 ; and

(b) the Fund to be established in respect of every Village Fuel Area referred to in paragraph (a) hereof in accordance with the provisions of regulation 12 of the Forest Regulations, 1940 ; shall be under the control of the Village Commission of the village within the lands of which such area is situate, such area being the area set out in the Schedule to the Minor State Forests Order, 1943.
