ORDER IN COUNCIL No. 2077

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 3 of the Forest Law, 1939, do hereby order as follows :—

1. This order may be cited as the Minor State Forests (Amendment) Order, 1943, and shall be read as one with the Minor State Forests Order, 1942, (hereinafter referred to as "the principal Order"), and the principal Order and this order may together be cited as the Minor State Forests Orders, 1942 and 1943.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of item 17 (relating to the village of Emba in the District of Paphos).

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE ACTING GOVERNOR.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations :—

1.—(1) These regulations may be cited as the Defence (Public Loans Laws, 1897 to 1940) Regulations, 1943.

(2) The Interpretation Law, 1935, shall apply to the interpretation of these regulations as it applies to the interpretation of a Law. 26 of 1935

2. Sub-section (4) of section 5 of the Public Loans Laws, 1897 to 1940, is hereby amended by the deletion therefrom of the words "The Statement shall, as early as practicable in each session, be laid on the table of Legislative Council, and shall be published in the *Cyprus Gazette* ;" (which occur in lines 5, 6, 7, and 8) and the substitution therefor of the words "The Statement of accounts showing the State of the Fund shall be published in the *Gazette* ;"
