## THE TRADING WITH THE ENEMY LAWS, 1939 TO 1941.

## GENERAL LICENCE MADE UNDER SECTION 3 AUTHORIZING THE PAYMENT OF FEES IN RESPECT OF PATENTS AND TRADE MARKS.

I, the Acting Governor, in exercise of the powers conferred on the Governor by section 3 of the Trading with the Enemy Laws, 1939 to 1941, and of every other power hereunto enabling, do hereby authorize—

- (a) the payment at the Office of the Registrar of Trade Marks of any fee payable in Cyprus on the renewal of the registration of a trade mark owned in part by an enemy provided such payment is made by or on behalf of a person who—
  - (i) is not an enemy, and
  - (ii) is part owner of the trade mark ; and
- (b) the payment at the Office of the Registrar of Patents or Trade Marks on behalf of either—
  - (i) a person who is a British subject or a national of an allied country and is an enemy merely because he is resident in any area which is in the occupation of a Power with whom His Majesty is at war, or
  - (ii) a body of persons controlled by any such person, of any fee payable in Cyprus on application for a patent or on application for or renewal of the registration of a trade mark ; and
- (c) the payment to a person not being an enemy of his charges and expenses for making a payment authorized by paragraphs (a) and (b) hereof.

2. The General Licence dated the 31st day of August, 1941, relating to the payment of fees in respect of patents, designs and trade marks, is hereby revoked without prejudice to anything done thereunder.

## THE VILLAGE AUTHORITIES LAWS, 1931 TO (No. 2) 1937.

## SPECIAL AUTHORIZATION UNDER SECTION 13A (1).
