

No. 114. THE GOVERNMENT WATERWORKS LAW, 1928.**REGULATIONS MADE UNDER SECTION 34.**

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 34 of the Government Waterworks Law, 1928, and of every other power hereunto enabling, do hereby make the following regulations:—

1. These regulations may be cited as the Government Waterworks (Kafizes) (Revocation) Regulations, 1943.

2. The Government Waterworks (Kafizes) Regulations, 1934 and 1938, are hereby revoked without prejudice to anything done or left undone thereunder.
