## THE INCREASE OF RENT (RESTRICTION) LAW, 1942.

## NOTIFICATION UNDER SECTION 4.

I, the Governor, in exercise of the powers conferred by section 4 of the Increase of Rent (Restriction) Law, 1942, do hereby—

- (a) establish in each of the Rent Restriction Areas set out in the first column of the Schedule hereto a Rent Assessment Board ;
- (b) appoint the persons whose names appear in the second column of the Schedule hereto to constitute the Rent Assessment Board for the Rent Restriction Area shown against their names in the first column of the said Schedule.

**NOTICE No. 96 UNDER CLAUSE 13.**

A.—The Schedule is hereby amended by the addition thereto of the following part:—

**“PART 71.—IMPORTED SALTED FISH OF ALL KINDS.**
