THE CONTAGIOUS DISEASES (ANIMALS) LAW, 1880. No. 128.

ORDER UNDER SECTION 2 (1) (1.).

In exercise of the powers vested in the Governor by section 2 (1) (1.) of the Contagious Diseases (Animals) Law, 1880, duly deputed to the Chief Veterinary Officer under section 4 of the said Law by paragraph 3 of the Notification No. 527 published in the Gazette of the 3rd July, 1931, I, Robert Moylan Gambles, Acting Chief Veterinary Officer, hereby order as follows:-

1. All sheep and goats in the Colony, with the exception of sheep and goats within the village areas of the villages set out in the Schedule hereto, shall

be inoculated with anthrax vaccine.

2. The inoculations shall be carried out by Veterinary Officers or by such

Vaccinators as may be appointed by me in writing in that behalf.

3. Every owner or person in charge of sheep or goats shall produce such sheep or goats for inoculation at such place and at such time as shall be appointed by a Veterinary Officer or Vaccinator as aforesaid by notice posted in a conspicuous place in the village concerned, and every such owner or person in charge shall render full assistance to the Veterinary Officer or Vaccinator in the inoculation of the sheep or goats as aforesaid.

THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:-

1. This order may be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Amendment (No. 3) Order, 1943, and shall be read as one with the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 to (No. 2) 1943, (hereinafter called "the principal Order"), and the principal Order and this order may together be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 to (No. 3) 1943.

2. The First Schedule to the principal Order is hereby amended by the addition to Item 77 of the words "and nuts" immediately after

the word "bolts".
