

No. 134. THE BURIALS LAWS, 1896 AND 1937.

ORDER BY THE GOVERNOR UNDER SECTION 1.

The Order published under Notification No. 352 in Supplement No. 3 to the *Gazette* of the 11th September, 1940, relating to the provision of a new burial-ground for the Orthodox-Christian community of the village of Kambi Pharmaka in the District of Nicosia, is revoked. (M.P. 1417/12/4.)

Whereas His Excellency the Governor is satisfied that the further use of the present burial-ground of the Orthodox-Christian community of the village of Kambi Pharmaka in the District of Nicosia is dangerous to the health of the village ;

And whereas it has been agreed between the said community of Kambi Pharmaka and the Orthodox-Christian community of the village of Pharmakas in the District of Nicosia that the said community of Kambi Pharmaka shall be permitted to use as a burial-ground the burial-ground of the said community of Pharmakas ;

Now, therefore, in exercise of the powers vested in him by section 17 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that from and after the 26th day of April, 1943, no burial shall take place in the burial-ground now in use by the said community of Kambi Pharmaka.

Made at Nicosia, this 15th day of April, 1943.

No. 136. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

THE CONTROL OF CATTLE AND MEAT ORDERS, 1942.

In exercise of the powers vested in me under clause 6 of the Control of Cattle and Meat Orders, 1942, I hereby prescribe that during the period between the 21st April, 1943 and 25th April, 1943, the Mukhtar of any village may issue permits for the slaughter of cattle sufficient to provide a maximum of 100 drams of carcass weight in respect of each Christian or non-Moslem inhabitant of the village in addition to the usual allowance of 50 drams in respect of each Moslem inhabitant.

No. 137. THE DEFENCE (AGRICULTURAL PRODUCE MOVEMENT AND CONTROL) ORDER, 1943.

NOTICE UNDER CLAUSE 8.

In exercise of the powers vested in me by clause 8 of the Defence (Agricultural Produce Movement and Control) Order, 1943, I hereby order that the Schedule to the Defence (Returns of Agricultural Produce) Order, 1943, be amended as follows :—

(a) In Nicosia District :

- (i) Next to the word " Mandres " add the word " (Morphou) ".
- (ii) The words " Selemani (Ayios Ioannis) Sina Oros " should be substituted by the words :  
" Selemani (Ayios Ioannis) "  
" Sina Oros "

(b) In Kyrenia District, the words " Krinia Sinaitikou ", " Plesia " and " Platimatis " shall be deleted.

(c) In Limassol District, next to the word " Prastio " there shall be added the word " (Limassol) ".

(d) In Paphos District :

- (i) next to the word " Trimithousa " add the word " (Khrysokhou) ".
- (ii) next to the word " Philousa " add the word " (Kelokedhara) ".
