THE CHANGE OF TITLES LAW, 1934.

ORDER IN COUNCIL No. 2070

## ORDER IN COUNCIL No. 2071

MADE UNDER SECTION 78.

C. C. WOOLLEY,

Governor.

Whereas the Mayor, Deputy Mayor, Councillors and Townsmen of Famagusta (hereinafter referred to as "the Municipal Corporation") have decided by the requisite majority of the members of the Council to transfer into the name of the Gymnastic Association "Evagoras", of Famagusta, the property described in the First Schedule hereto in exchange for the property described in the Second Schedule hereto:

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 78 of the Municipal Corporations Laws, 1930 to (No. 2) 1942, and with the advice of the Executive Council, has been pleased to sanction and hereby sanctions the transfer by the Municipal Corporation of the property described in the First Schedule hereto into the name of the Gymnastic Association "Evagoras", of Famagusta, without any charge, on condition that the said Gymnastic Association "Evagoras" shall transfer into the name of the Municipal Corporation the property described in the Second Schedule hereto without any charge.
