**The Quarantine Law, 1932.****NOTIFICATION UNDER SECTION 4.**

In exercise of the powers vested in him by section 4 of the Quarantine Law, 1932, or otherwise, His Excellency the Governor is pleased to declare and hereby declares that the local areas in the first column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall, as from the date hereof, be subject to the measures prescribed by the Quarantine Regulations, 1932 to 1936, with respect to the dangerous infectious diseases in the second column of the Schedule hereto.

The Notification No. 51, published in Supplement No. 3 to the *Gazette* of the 25th February, 1943, is hereby cancelled.

No. 170. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Milling of Flour) Amendment (No. 2) Order, 1943, and shall be read as one with the Defence (Milling of Flour) Orders, 1942 to 1943, (hereinafter referred to as “the principal Order”), and the principal Order and this Order may together be cited as the Defence (Milling of Flour) Orders, 1942 to (No. 2) 1943.

2. Clause 3 of the principal Order is hereby amended by the deletion therefrom of the words “one quarter” in the 3rd line thereof and the substitution therefor of the words “one half”.
