

No. 171. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows :—

1. This Order may be cited as the Defence (Returns of Stocks of Imported Sulphur) Order, 1943.

2. Within seven days of the date of the publication of this Order in the *Gazette* any person who has in his possession or under his control any imported sulphur in excess of 100 kilogrammes shall complete and deliver to me a return in the form and containing the particulars set forth in the Schedule hereto.

3.—(a) From and after the date of the publication of this Order in the *Gazette*, no person who has in his possession or under his control any quantity of imported sulphur in excess of the quantity mentioned in clause 2 of this Order shall sell or dispose of any imported sulphur except under a special permit issued under my hand or under the hand of the Government Viticulturist and Wine Expert.

(b) Any special permit issued under the provisions of paragraph (a) hereof may contain such terms and conditions as may be specified therein.

4. Every person shall permit such person as I or the Commissioner of the District may authorize in writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

5. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this Order ;
- (b) makes any return required to be made under the provisions of this Order which is false in any material particular ;
- (c) fails to comply with any condition in any special permit issued under this Order ;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order ;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.

6. Nothing in this Order shall apply to any sulphur which is held by any Co-operative Society.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations 1940 to (No. 1) 1943, I hereby order as follows :—

1. This Order may be cited as the Defence (Control of Threshing Boards) Order, 1943.

2. For the purposes of this Order “ threshing board ” means a board used for threshing commonly called *doumani*.

3. Not later than 7 days after the publication of this Order in the *Gazette* every person who has in his possession or under his control, any threshing boards exceeding 3 in number, shall complete and deliver to the Timber Controller at Nicosia a return in the form set forth in the Schedule hereto.

4.—(a) From and after the date of the publication of this Order in the *Gazette* no person who has in his possession or under his control any threshing boards in excess of the quantity mentioned in clause 3 of this Order, shall remove, make use of, sell, dispose of or otherwise deal with any such threshing boards save under a permit issued under the hand of the Timber Controller or a Timber Control Officer.

(b) A permit under this Order may be issued, refused, amended or cancelled at the discretion of the Timber Controller or the Timber Control Officer to whom application is made for the issue thereof and may contain such terms and conditions as may be specified therein.

5. Every person shall permit a Timber Control Officer or such persons as the Timber Controller may authorize in writing in that behalf to enter upon his premises for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

6. Any person who—

- (a) acts in contravention of, or fails to comply with any of the provisions of this Order; or
- (b) makes any return required to be made under this Order, which is false in any material particular; or
- (c) fails to comply with any term or condition contained in any special permit issued under this Order; or
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.
